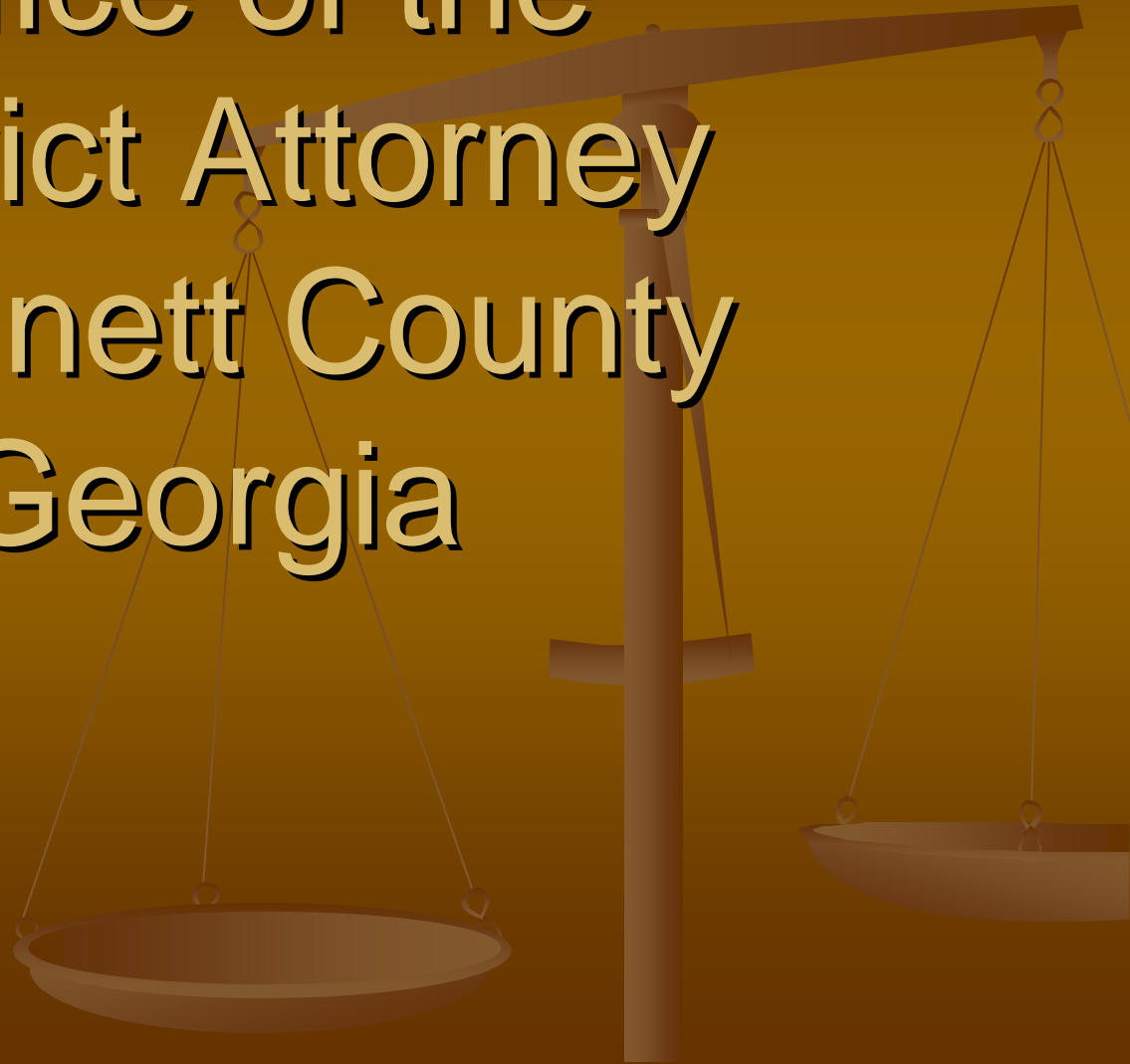

REQUIRED MANDATES



- Represent the State in criminal cases in the Superior Court (includes investigation, initiation, negotiation & disposition of cases)
- Represent the State in appeals from Superior Court (includes legal research, brief writing and oral argument before appellate courts)
- Represent the State in criminal cases in Juvenile Court (includes investigation, initiation, negotiation & disposition of cases)
- Represent the State in Civil Forfeiture Actions based on criminal conduct (includes investigation, initiation, negotiation & disposition of cases)
- Statutorily mandated victim services
- Welfare / Medicare Fraud prosecution, settlement and collections
- Child fatality review and protocol
- Sexual Assault Protocol
- Miscellaneous Statutory duties (i.e. representing State in Habeas Corpus Actions)

LEVEL MANDATED SERVICES ARE CURRENTLY PROVIDED AND NON MANDATED SERVICES CURRENTLY PROVIDED:

The District Attorney's Office is currently meeting all statutorily mandated service requirements at service levels which attempt to minimize delay in case disposition. However, due to projected caseload increases and increased complexity of individual cases, backlogs are increasing in certain courts.

Increased backlogs mean increased jail costs, increased costs of locating and transporting witnesses as well as increased defense costs if the defendant is indigent. The 2010 budget projection is based on current caseload numbers and will allow only current levels of service.

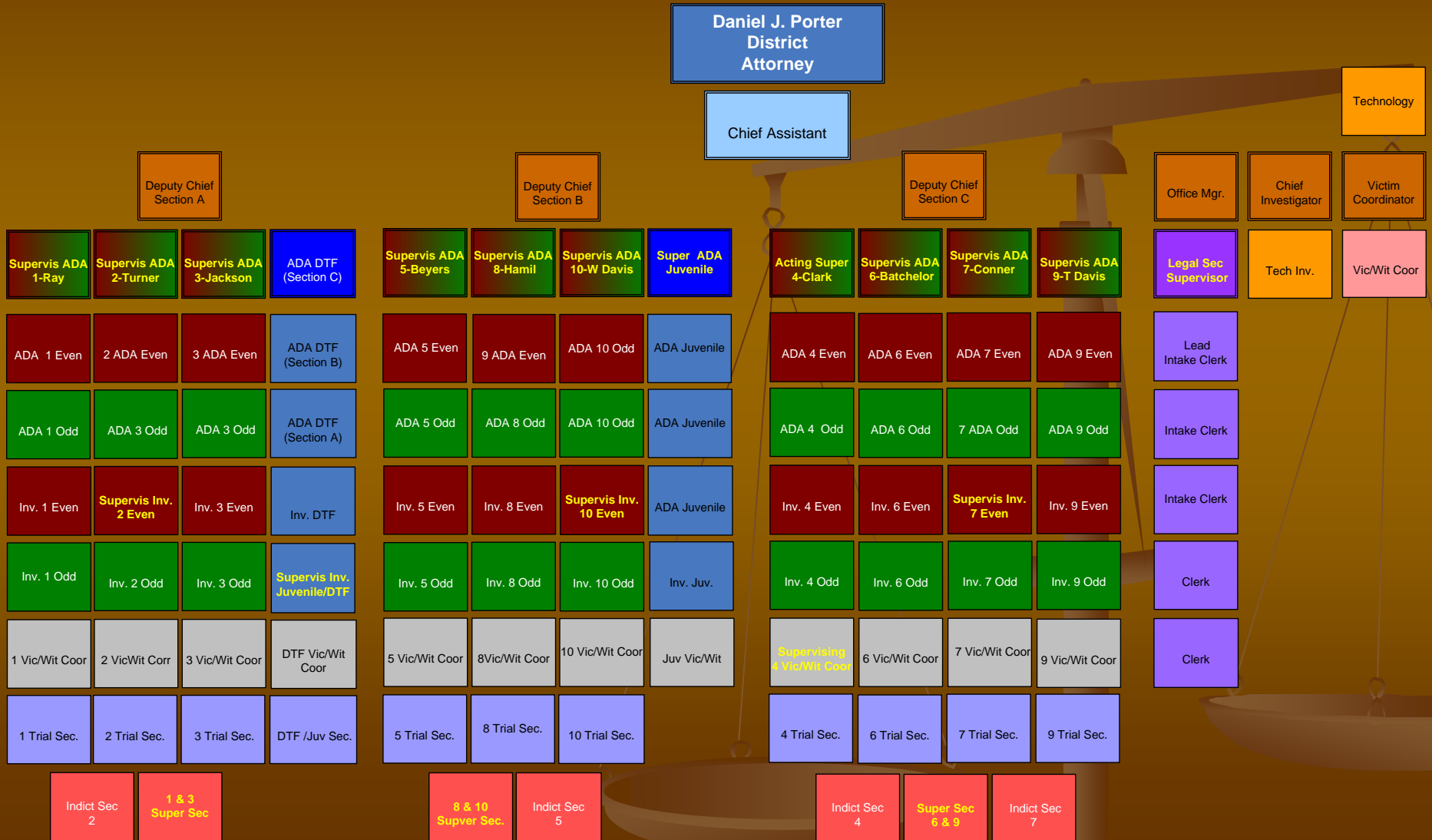
The District Attorney's Office provides no service which is not mandated by Georgia law.




ORGANIZATIONAL CHART





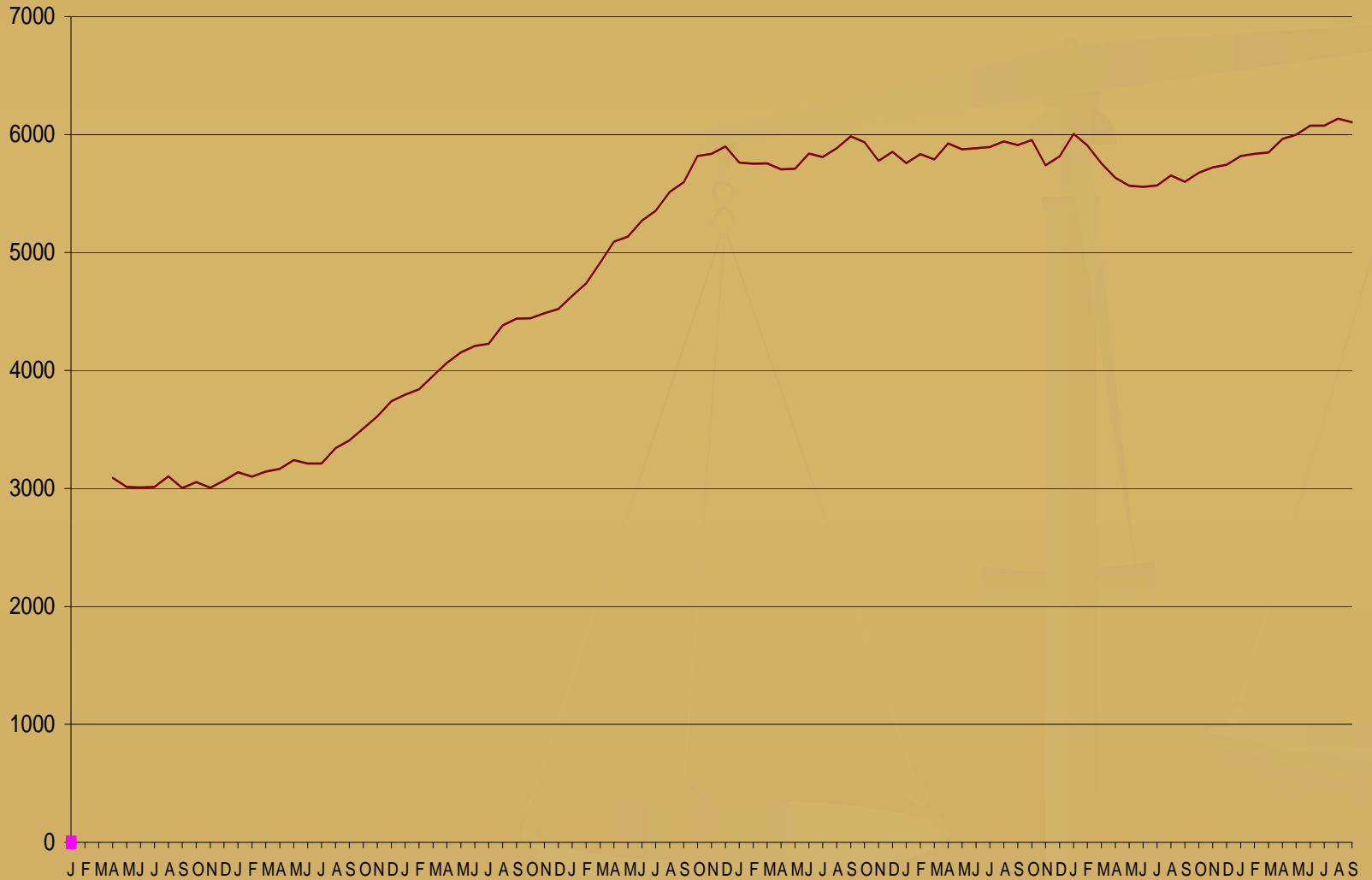

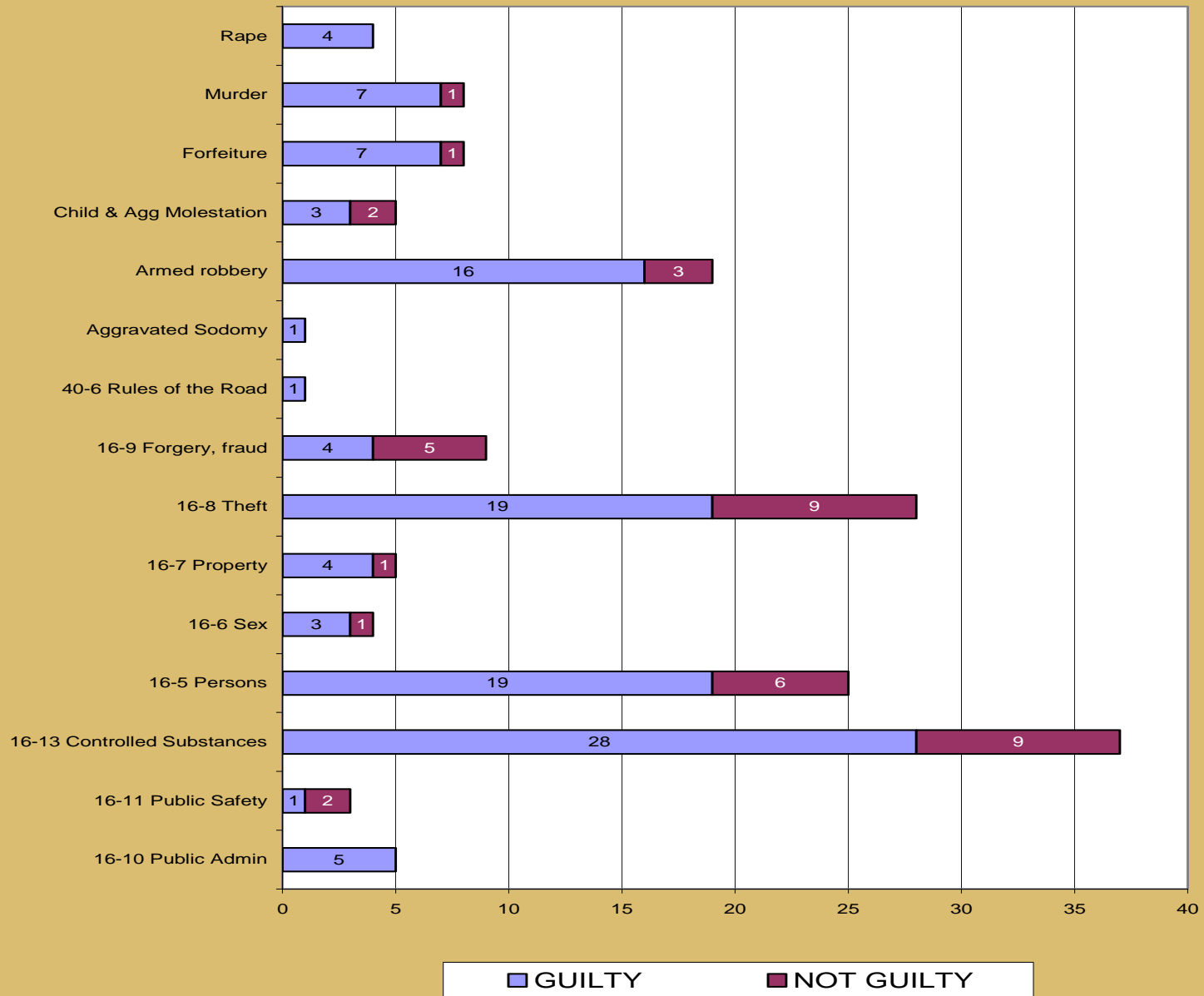

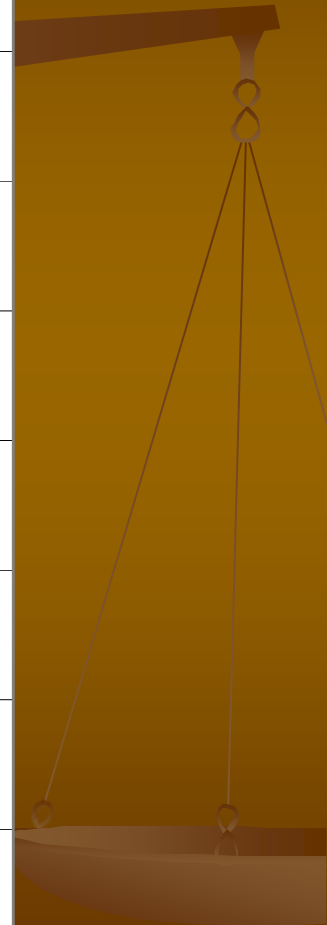
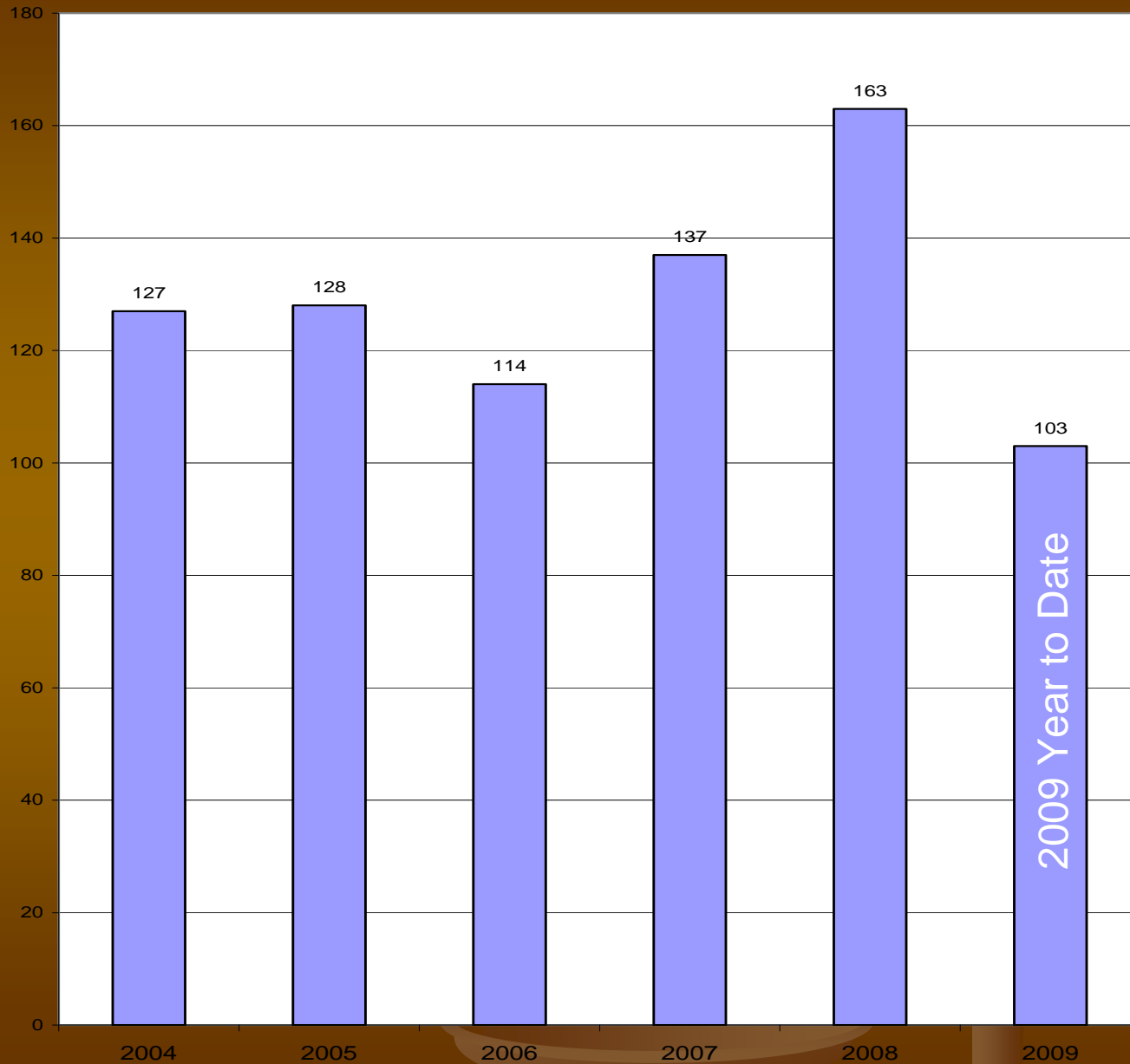
PENDING CASES

APRIL 2000 TO PRESENT



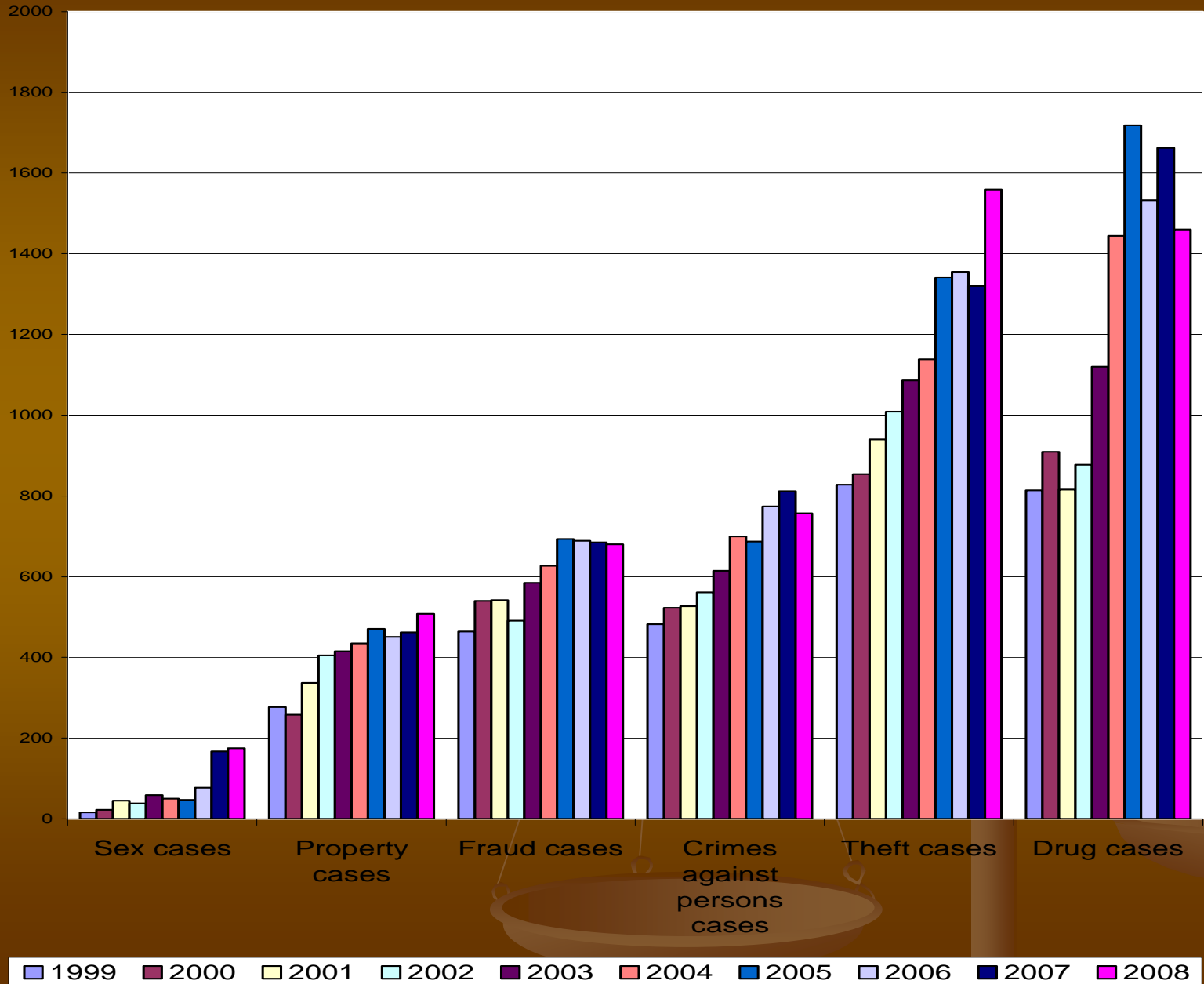
2008 TRIAL VERDICTS BY CASE TYPE

9 YEAR INCREASE IN CRIMINAL CASE LOAD



LOSS OF CRITICAL SERVICES IF SUFFICIENT FUNDING IS NOT PROVIDED

If sufficient funding is not provided or if the 9% budget cut required for 2010 is enacted then the only option to reach these requirements is to reduce personnel cost by layoffs or furloughs.

Loss of staff will result in

- Increased delay in bringing cases to trial
- Possible release of accused criminals based on delay
- Possible shut down of courts due to FLSA requirements for furloughs

Finally, the loss of staff will leave this office unprepared to handle the increase in cases that is sure to come.
