- Operation of the county jail. Average daily inmate population was 2,691. Booked in 39,899 people.
- Service of Civil process. Received 88,569 papers/orders for service.
- Service of arrest warrants. Maintain 26,534 warrants for service.
- Court Security. Staffed 9,923 court sessions and screened 559,185 people through security.
- Sex Offender Registry. 300 offenders in Gwinnett County.
- GCIC/NCIC entry and validation of warrants and orders.

- Sex Offender Registry. Currently oversee 330 sex offenders.
- GCIC/NCIC entry and validations for warrants and orders.
